WHEREAS, the City Council has updated its Special Activity Permit at Chapter 12, Article IV, Division 1 of the Steamboat Springs Revised Municipal Code; and

WHEREAS, Section 12-82(2) of the new code requires that policies for special activity permits shall be adopted by City Council resolution; and

WHEREAS, the Steamboat Springs City Council has a vision to preserve our past while assuring an economically, culturally, and environmentally sustainable future; and

WHEREAS, the number of special events in our community continues to increase over time and the City would like to minimize community impacts from special events and ensure public safety of residents and visitors; and

WHEREAS, the City supports high quality event planning and fun event experiences.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF STEAMBOAT SPRINGS, COLORADO, THAT:

1. The City Council of the City of Steamboat Springs hereby approves the **City of Steamboat Springs Special Activity Venue Policy**, a copy of which is attached hereto as Exhibit "A", and by this reference made a part hereof.

City of Steamboat Springs Event Venue Policy

- 1. Howelsen Amphitheater: If a large (100+ people) event is held in this venue, the following venues are unavailable for an independent event:
 - a. The Lodge
 - b. Howelsen Parking Area A (lodge parking area)
- 2. Vanatta and Klumker Fields: If the fields are in use, the following venue is unavailable for an independent event:
 - a. Howelsen Parking Area A
- 3. Howelsen Parking Area A (lodge parking): If an event is held in this venue, the following venues are unavailable for an independent event:
 - a. Howelsen Lodge
 - b. Vanatta Field
 - c. Klumker Field
- 4. Howelsen Lodge: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. Howelsen Parking Area A
- 5. Howelsen Beach: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. Howelsen Parking Area C
- 6. Howelsen Parking Area C: If an event is held in this venue, the following venues are unavailable for an independent event:
 - a. Howelsen Beach
 - b. Rodeo Arenas
- 7. Rodeo Arenas: If an event is held in this venue, the following venues are unavailable for an independent event:
 - a. Rodeo Parking Area F
 - b. Howelsen Parking Area C
- 8. Howelsen Parking Area F: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. Rodeo Arenas

- 9. Howelsen Hill Parking Lots B, D and G will not be considered for stand-alone special activities but may be used in association with other Howelsen Hill venues
- 10. Howelsen Parking Area E
 - a. No exclusive use some parking must remain for non-event venue purposes, including downtown and the ice arena.
- 11. Yampa Street: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. Howelsen Parking Area E
- 12. Little Toots Park: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. 12th street
- 13.12th Street: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. Little Toots Park
- 14. Rodeo & Amphitheater: If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. All Howelsen parking areas
- 15. Rodeo & Amphitheater & Sports Field If an event is held in this venue, the following venue is unavailable for an independent event:
 - a. All of the other venues at Howelsen

The City Manager may provide an exemption to any portion of this policy on a case-bycase basis.
