## I. REQUEST/ISSUE & BACKGROUND INFORMATION:

This is an update on Planning Commission's discussion of a draft Short-Term Rental Overlay Zone. Please refer to Attachment 1 for a summary and comparison of two options being considered by Planning Commission. Key definitions, an outline of the STR Licensing program, and implementation details are also included.

## II. SUMMARY AND ALTERNATIVES:

Staff is looking for feedback from Council regarding the two draft Overlay Zone options.

#### III. STAFF RECOMMENDATION:

This is an update. Staff is requesting feedback at this time.

#### IV. FISCAL IMPACT:

Implementation of a new Short-Term Rental policy and licensing requirement will have fiscal impacts; however, revenues from annual license fees are anticipated to cover the costs of administering and enforcing the new policy and licensing. Anticipated costs include:

- Development of a STR License application/renewal process and review/approval workflow in CityView software. (Upfront cost)
- Public outreach to inform property owners and property managers of new process, requirements, and standards. (Upfront cost)
- Annual contract services for STR monitoring, identification, and auditing (Granicus). (Ongoing cost)
- Increased contract legal services for the City's Municipal Court Prosecutor. (Ongoing cost)
- Increased staffing and potentially a software upgrade for Municipal Court. (Ongoing and potentially one-time software cost)
- Additional enforcement and inspection staff depending, if needed. (Ongoing cost)
- Increased staffing for sales tax licensing, collection, and auditing, if needed. (Ongoing cost)

#### V. LEGAL ISSUES:

There are no legal issues at this time.

## VI. CONFLICTS OR ENVIRONMENTAL ISSUES:

There are no apparent conflicts or environmental issues at this time.

## VII. CONSISTENCY WITH COUNCIL GOALS AND POLICIES:

This item is directly related to Council's goal to address the City's short-term rental issue through adoption of regulatory policies, enforcement rules, licensing procedures, and establishment of a fee structure.
