**AN ORDINANCE EXTENDING THE TERM OF THE MORATORIUM RELATING TO VACATION HOME RENTAL USES IMPOSED BY ORDINANCE NOS. 2819 AND 2822**

**WHEREAS**, the City of Steamboat Springs has in the exercise of its home rule authority pursuant to Article XX, Section 6 of the Colorado Constitution adopted a Community Development Code (“CDC”) that classifies short term rentals of single-family dwelling units and duplexes for more than two instances or thirty days annually (“Vacation Home Rental”) as a lodging use that is lawful use in various zone districts only if the property owner obtains a Vacation Home Rental Permit through the Limited Use Requiring a Permit process; and

**WHEREAS**, the City of Steamboat Springs is experiencing a severe shortage of housing for the local workforce at all income levels and the City Council finds that the diversion of the existing housing stock and newly constructed housing into the short term rental pool via the Vacation Home Rental permitting process and otherwise necessarily contributes to the City’s housing shortage; and

**WHEREAS**, the City Council finds that Vacation Home Rental uses in residential neighborhoods can have a substantial and negative impact to residential neighborhoods due to excessive noise, increased traffic, trash left unsecured from wildlife, and also through the erosion of community values and neighborhood character by replacing long term neighbors with short term visitors; and

**WHEREAS**, the City Council is engaged in a comprehensive review of City policy regarding Vacation Home Rentals and other short term rentals that may include licensing, contracting for short term rental compliance services, an inspection program, revenue measures, increased staffing, modifications to land use regulations, and other regulatory measures; and

**WHEREAS**, the City Council hereby finds and determines that imposing a moratorium on receiving applications for, review, and issuing or approving permits for Vacation Home Rental uses is necessary to preserve the status quo while the Planning Commission and City Council completes its review of the City’s regulatory framework for short term rentals generally and Vacation Home Rental uses in particular and that preserving the status quo will promote the public health safety and welfare by allowing for a deliberate and well-reasoned decision-making process; and

**WHEREAS**, the City Council finds that the impact of a temporary moratorium on Vacation Home Rental uses will have a limited impact on the economic interests of the owners of single family dwelling units and duplexes because property suitable for Vacation Home

Rental uses are equally suitable for residential uses, either owner occupied or through the long term rental market; and

**WHEREAS**, the City Council finds that review of the City's Vacation Home Rental regulations and consideration and adoption of amendments will not be complete until June 30, 2022; and

**WHEREAS**, the City Council on June 10, 2021 adopted an emergency ordinance imposing a ninety day moratorium on the issuance of permits for Vacation Home Rental Uses; adopted Ordinance No. 2819 on August 30, 2021 to extend the moratorium through October 31, 2021; and on October 19, 2022 adopted Ordinance No. 2822 to extend the moratorium through January 31, 2022 and to narrow the geographic scope of the moratorium so as to exclude certain neighborhoods characterized by short term rental uses; and

**WHEREAS**, the City Council hereby finds that it is necessary to the immediate preservation of the public health, safety, and welfare to adopt this ordinance extending the moratorium on the issuance of Vacation Home Rental permits imposed by Ordinances Nos. 2819 and 2822 through June 30, 2022; and

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STEAMBOAT SPRINGS, COLORADO:**

**SECTION 1.** The term of the moratorium imposed by Ordinances No. 2819 and as amended by Ordinance No. 2822 is hereby extended through June 30, 2022.

**SECTION 2.** The City Council hereby finds, determines, and declares that this ordinance is necessary for the immediate preservation of the public peace, health and safety.

**SECTION 3.** All ordinances heretofore passed and adopted by the City Council of the City of Steamboat Springs, Colorado, are hereby repealed to the extent that said ordinances, or parts thereof, are in conflict herewith.

**SECTION 4.** Pursuant to Section 7.6(h) of the Charter of the City of Steamboat Springs, Colorado, this ordinance shall take effect five (5) days following publication after final approval.
